Director Marx provided a short overview of proposed legislation relating to the Alaska Workers' Compensation Appeals Commission.

# IX. 2015 Annual Report

Director Marx reviewed statistics from the Division's 2015 annual report, a compilation of statistics and benefit data obtained from insurers and self-insured employers pursuant to AS 23.30.155(m).

- A total of \$301.2 million in workers' compensation benefits was paid out in calendar year 2015, an increase of 2 % over the previous year.
- Medical benefits totaled \$162.5 million, up 17.8 % from the prior year.
- Indemnity benefits totaled \$73 million, up 11 %.
- Legal costs decreased 4% \$15.5 million.
- Reemployment benefits increased 3%, to \$13.5 million.
- Injury frequency increased, with 19,909 injuries reported, up 6.5% from the previous year.

Rhonda Gerharz, Chief of the Special Investigations Unit (SIU), gave an overview of the SIU's 2015 performance.

Velma Thomas, Program Coordinator, reviewed the funds and programs administered by the Division: the Benefits Guaranty Fund, the Fishermen's Fund, the Second Injury Fund, the Self-Insurance Program, and the Proof of Coverage Program.

Mark Kemberling, Reemployment Benefits Administrator, reviewed the 2015 performance of the Reemployment Benefits Program.

Amanda Eklund, Chief of Adjudications, reviewed the 2015 performance of the Adjudications Section.
