**RESOLUTION TO RECOMMEND STATE TRAINING EMPLOYMENT PROGRAM
(STEP) APPLICATIONS FOR FUNDING FISCAL 2015**

WHEREAS, the Alaska Workforce Investment Board (AWIB) is a private industry-driven public organization that is accountable through its members, including representatives from business and industry, education, organized labor, and government, to the residents, the Legislature and the Governor of Alaska;

WHEREAS, the AWIB acts as the lead state planning and coordinating entity for state human resource programs involving employment training, career and technical education, and workforce development;

WHEREAS, the AWIB advises the Governor, the Commissioner of the Department of Labor and Workforce Development, and the Alaska State Legislature;

WHEREAS, the AWIB is designated in statute and regulation to assist the Department of Labor and Workforce Development by recommending applicants for funding under the STEP; and

WHEREAS, the AWIB members reviewed all STEP applications and determined the ranking of the applications for the purposes of funding;


