This Program Directive, PD 07-02, is formal notice that the Alaska Department of Labor & Workforce Development, Division of Labor Standards & Safety recognizes and will implement the corrections to the final rule having to do with Hexavalent Chromium [Cr(VI)]. Note references to 29 CFR parts 1915 – 1918 are out of Alaska's jurisdiction and will not be adopted.

29 C.F.R. 1910.1026 and 29 C.F.R. 1926.1126 are occupational safety and health standards in this state, as revised in this section and except as provided in 8 AAC 61.1145 - 8 AAC 61.1170.

a. **8 AAC 61.1100. Additional air contaminants standards** does not reference Hexavalent Chromium (Cr(VI)) in Table Z-1-A of this section which are the Alaska standards to test limits for air contaminants in place of Table Z-1 contained in 29 C.F.R. 1910.1000, as amended.

Effective Date: The effective date of any amendments to the Code of Federal Regulations (CFR) adopted by reference in this section of the Alaska Administrative Code have the same effective date as published in the Federal Register.
