Subject: OSHA Strategic Partnership Program for Worker Safety and Health

Program Directive (PD) 14-01 revises the OSHA Strategic Partnership Program for Worker Safety and Health (OSPP) procedures.

This PD cancels AKOSH PD 05-06 for OSHA Instruction CSP 03-02-002 Strategic Partnership Program for Worker Safety and Health, which was effective beginning February 10, 2005.
