Directive; CPL 02-02-078

AKOSH Program Directive 16-01 updates procedures and scheduling for exposure of workers to tuberculosis and is adopted identical to the federal directive CPL 02-02-078. This PD incorporates the CDC 2005 Guidelines. It is effective immediately and cancels AKOSH Program Directive 96-22.
