Errata to Alaska Workers' Compensation Appeals Commission Final Decision No. 287, issued at Anchorage, Alaska, on May 28, 2021.

Upon the Alaska Workers' Compensation Appeals Commission's (Commission) own motion that Final Decision No. 287, issued on May 28, 2021, is actually a Memorandum Decision on Petitions for Review, which is a non-final order of the Commission, the Commission makes the following clarifications.

On November 4, 2020, Allison Leigh filed a Notice of Appeal from Alaska Workers' Compensation Board (Board) Interlocutory Decision and Order No. 20-0071 (*Leigh VIII*) and a Notice of Appeal from Board Interlocutory Decision and Order No. 20-0082 (*Leigh IX*). On November 13, 2020, the two appeals were consolidated.

As stated in Dec. No. 287:

Although the Commission has handled Ms. Leigh's petitions for review as appeals, they were properly petitions for review since both decisions of the Board were interlocutory decisions and orders and, thus, not final decisions from which an appeal may be made. By considering the petitions for review as appeals, the parties briefed the issues and oral argument was held.

Thus, the mistake in considering Ms. Leigh’s petitions for review as appeals was a harmless error.<sup>1</sup>

Upon its own motion, the Commission corrects Final Decision No. 287 to be titled “Memorandum Decision on Petitions for Review No. 287.” All references in Decision No. 287 to Ms. Leigh’s “appeals” should be construed as “petitions for review.” Also, the procedures for petitioning the Alaska Supreme Court for review, set out at the end of the decision, are changed as follows:

This is not a final Commission decision or order on the merits of an appeal from a final Board decision or order on a claim. This is a non-final order of the Commission on the merits of a petition for review of a non-final Board decision. The effect of this order is to allow the Board to proceed toward a hearing on the merits of the employee’s workers’ compensation claim. The petitioner may still appeal a final Board decision when it is reached on the claim.

This order becomes effective when distributed (mailed) unless proceedings to seek supreme court review are instituted (started). For the date of distribution, see the box below.
