ORDER AND DECISION NO. 26D PERTAINING
TO UNIT ALLOCATION OF INDIVIDUALS

FINDINGS OF FACT AND CONCLUSIONS

On February 14, 1977, and on March 1, 1977, the Division of Personnel, Department of Administration, State of Alaska sent to the Labor Relations Agency lists of Position Control Numbers which the State proposed to transfer from the Supervisory to the General Government Unit or vice-versa.
