**CERTIFICATE OF FITNESS
APPLICATIONS AND HOURLY REQUIREMENTS**

APPLICATIONS

For those applying for testing: all documentation submitted as verification of your hours of experience must be on company letterhead or an Experience Verification Form, and **must be notarized**. We need: (1) a current application, (2) verification of the appropriate number of hours for the license requested, and (3) the \$50 application/test fee. All three items must be submitted together as a packet BEFORE we can schedule a test date. You must turn in your application at least two weeks prior to the date you would like to test.

Trainee applicants: must have (1) a letter from the employer on company letterhead or a notarized statement, stating that the employee "will be working under the direct supervision of an Alaska certified journeyman at all times," (2) a current completed application. This will be required each time the trainee renews his certificate of fitness. The applicant must certify that he/she has never been licensed or worked as a journeyman in any jurisdiction.

HOURLY REQUIREMENTS

Electrical Journeyman Certificate of Fitness

Requires 8000 hours of work in the trade; a minimum of 6000 of which must be commercial/industrial. Up to 1000 hours of trade-related classroom training can be substituted for 1000 hours of the 6000 commercial/industrial hours. Up to 2000 hours can be residential. No maintenance hours apply.

Electrical Residential Certificate of Fitness

Requires 4000 hours of work in the trade. Up to 500 hours of trade-related classroom training can be substituted for 500 hours of the 4000 hour requirement. This license allows the holder to act as a journeyman on residential sites only. The holder will be a trainee on commercial sites. No maintenance hours apply.

Plumber Journeyman Certificate of Fitness

Requires 8000 hours of work in installation of commercial/residential plumbing. Up to 1000 hours of trade-related classroom training may be substituted for time in the field. No maintenance hours apply.

Plumber Restricted PG (Gas) Certificate of Fitness

Requires 4000 hours of work in the trade. A minimum of 2000 hours must be in the installation of fuel gas piping. May substitute 2000 hours of commercial/industrial plumbing installation. Up to 500 trade-related classroom hours may be substituted for the plumbing installation experience. No maintenance hours apply.

Plumber Restricted PU (Utility) Certificate of Fitness

Requires 1,000 hours of work in installation of water, sewer, or storm lines; may substitute up to 125 trade-related classroom hours.

Boiler Operator Certificate of Fitness: 1st Class

Requires two (2) years' experience in the trade or working in the trade with a 2nd class license for one (1) year. Must pass test.

Boiler Operator Certificate of Fitness: 2nd Class

Requires one (1) year experience working in the trade with a 3rd class license for one (1) year. Must pass test.

Boiler Operator Certificate of Fitness: 3rd Class

Requires six (6) months working in the trade or six (6) months of boiler training. Must pass test.

Boiler Operator Certificate of Fitness: 4th Class

No hourly requirement. Must pass test.

EXAMS

Given by appointment only. Call the Mechanical Inspection office in Anchorage, Fairbanks or Juneau to schedule an appointment. Note: Anchorage schedules all areas other than Fairbanks or Juneau. A picture ID must be presented at the time of testing. There is a four (4) hour maximum time limit on all exams. A score of at least 70 % is required for passing. If a passing score is not obtained you must wait 30 days from the date of your last exam. Exams are graded in Anchorage, please wait 5 - 7 working days before calling the office for exam results of tests taken in any city other than Anchorage.

FEES

New certificates are \$210; \$50 application fee plus \$160 for the 2-year certificate. Test fees are \$50 for approval and to schedule a date to test, then \$160 after passing the test for the 2-year certificate. Fees paid in the Anchorage office may be made in cash, check, money order or credit card.

RENEWALS

All electrical, plumbing, and lineman certificate of fitness renewals are \$160 per 2-year renewal. If the certificate has expired more than 90 days, but less than two years, you must; re-apply and pay a \$50.00 re-application fee (total of \$210). If your license has expired more than 2 years you are required to re-apply, re-test, and pay \$210. You must also send a current passport size (2"x2") photo of you, this may be a Polaroid snap shot. A trainee certificate of fitness renewal requires \$160.00 per 2-year renewal and a letter from the employer on company letterhead or a notarized statement, stating that the employee "will be working under the direct supervision of an Alaska certified journeyman at all times."

Electrical Journeyman: As of January 1, 2001: Electrical Journeymen will be required to attain at least 16 hours of continuing education within the preceding 24-month period before the request for renewal is made. Proof of completion of the 16 hours of training must be sent with your renewal request for your Certificate of Fitness.
