Subject: **SST-06 (CPL 02) Site Specific Targeting - deletions and deferrals**

This Program Directive, PD 06-13, is notice that Alaska Department of Labor & Workforce Development, Division of Labor Standards & Safety shall incorporate in its inspection program the procedures for deletions and deferrals as set out in Directive 06-01 (CPL 02) B(1)-(B(3)).

Effective Date: June 12, 2006

Expiration Date: June 12, 2007 or earlier if cancelled.

Background: In response to OSHA Directive 06-01 (CPL 02) The State of Alaska has developed a targeting system based on current Workers' Compensation data and does not intend to use SST-06 other than what is set out in B(1)-B(3).

In September 2002, Alaska adopted program directive PD 03-01 which established a state-specific inspection targeting plan, known as the High-Hazard Targeting Plan (HHT). At that time, AKOSH PD 02-01 which implemented SST-10 was canceled.

CPL 02-VII

B. Deletions and Deferrals.

1. In accordance with CSP 02-00-001, the Consultation Policies and Procedures Manual (Chapter I, Section IV), States must establish a recognition and exemption program and adopt compliance policies and procedures related to the implementation of the Occupational Safety and Health Administration Compliance Assistance Authorization Act of 1998, which amended the Occupational Safety and Health Act

of 1970, and 29 CFR Part 1908, as amended on October 26, 2000. As related to inspection targeting, these include:

- Discretionary authority for deferring programmed inspections for employers working toward exemption program participation (comparable to pre-SHARP) from programmed inspection lists for up to 18 months (§1908.7(b)(4)(i)(A)). See paragraph XII.B.4. of this Notice.
 - XII.B.4 Pre-SHARP. If an establishment is in pre-SHARP status, that is, in the process of meeting the criteria of an OSHA Consultation Safety and Health Achievement Recognition Program (SHARP), it may be deferred for up to 18 months while the employer is working to achieve recognition and exemption status. See 29 CFR 1908.7(b)(4)(i)(A) and CSP 02-00-001, Chapter 7, paragraph III.

- Deletions for State recognition and exemption program participants (comparable to SHARP) from programmed inspection lists (§1908.7(b)(4)(i)(B)). See paragraph XIII.D. of this Notice.
 - XIII.D. VPP or SHARP. If the establishment is an approved participant in OSHA's Voluntary Protection Programs (VPP), or in OSHA Consultation's Safety and Health Achievement Recognition Program (SHARP), it is to be deleted from the inspection list.
