Subject: **PSM Covered Chemical Facilities National Emphasis Program**

This Program Directive, PD 10-14, is formal notice that the Alaska Department of Labor & Workforce Development, Division of Labor Standards & Safety recognizes and will implement the PSM Covered Chemical Facilities National Emphasis Program, OSHA Directive number 10-05 (CPL 02).

This directive becomes effective September 15, 2010. This directive describes policies and procedures for implementing a pilot National Emphasis Program (NEP) to reduce or eliminate the workplace hazards associated with the catastrophic release of highly hazardous chemicals.

This directive cancels PD 10-02 "PSM Covered Chemical Facilities National Emphasis Program" from September 21, 2009 (OSHA Directive number CPL-2 (09-06)).
