VPP Safety Coordinators,

### NEWS:

- Christian Hendrickson is now the backup VPP Coordinator for AKOSH. Many of you have already met Christian, and he's a valuable asset to our program. As he's also our PSM specialist, he'll be on most of our visits in that capacity.
- It's been a hot summer. Extreme heat, fires, and lots of smoke in many parts of the state. While Alaskans rarely have to think about heat stress except in specific work environments, it has come up quite a bit for us in the past several weeks. There are resources out there for determining stay times in hot environments and remember to include factors such as work activity, humidity, air movement, radiant energy, and whether the worker is acclimatized to high heat.
- Related to fires, we've had more than an average amount of smoke in the air this summer. While this may not be an actual workplace hazard, it can have negative health effects on employees, and the response that each employee has to smoke exposure can be very different. We're looking for suggestions and best practices to use for a work site when the smoke becomes especially bad so that a resource document can be created for next summer.
- Alaska needs it's own VPP logo. We've traditionally used the national logo, but something that represents our state would be nice. If any of you have some graphic design experience, and have suggestions, I'd love to see them.
- This newsletter will have special quarterly issues that go out to not only the VPP participants, but also to our CHASE and SHARP participants. It is my hope that this brings a larger team of safety specialists together and gives everyone a better understanding of all the programs we offer.
- In September, I'd like to coordinate a meet-and-greet in Anchorage.
